**BENINGBROUGH PARK.** A complaint has been received about anglers arriving in the early hours and parking by the stile access to the water. This was obviously before the “close season”. It should be noted that parking is available for anglers over the cattle grid, then left and left again, parking neatly to the hedge. When the season opens again this is the only parking that should be used by anglers and parking on the approach road and by the gates and stile is expressly prohibited.

Please respect your riparian owners conditions for lease of waters.

**WORK PARTY AT BURN ROAD.** A further work party has visited this venue and the ‘bouncy castle’ remains have been destroyed. Due to planned improvements the vegetation (branches etc.) over the gate need removing to allow vehicular access.
